

PRIVACY POLICY

This is the Privacy Policy of Slide Score B.V. (hereinafter referred to as "Slide Score," "we," "us" or "our"), a company having its address at Ottho Heldringstraat 202B, 1066AZ Amsterdam. Slide Score is registered with the Chamber of Commerce under number 72220147. Our Privacy Policy explains how we collect, use, share and protect information in relation to our website www.slidescore.com (the "**Service**"). We collect this information when you visit our website with your computer, tablet or mobile phone ("**Computer**"). We process personal data in a manner that is in accordance with the General Data Protection Regulation (the "**GDPR**"), the GDPR-based legislation and the other current privacy legislation.

By using the Service, you understand and agree to the collection and use of information in accordance with this Privacy Policy. Our Privacy Policy applies to all visitors, users, and others who access the Service ("**Users**").

What kinds of information do we collect?

Information you provide

We collect the following information you provide us with directly:

- a. Your password and e-mail address when you register for an Slide Score account;
- b. Profile information that you provide for your user profile;
- c. Communications between you and Slide Score (e.g., we may send you Service-related emails);

Log file information

We collect information that your browser sends whenever you visit our Service. This log file information may include information such as your computer's Internet Protocol address, browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages and other statistics.

General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Slide Score's legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- Slide Score needs to perform a contract with you
- You have given Slide Score permission to do so
- Processing your personal information is in Slide Score legitimate interests
- Slide Score needs to comply with the law

Slide Score will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. If you wish to be informed what Personal Information we hold about you and if you want it to be removed from our systems, please contact us.

In certain circumstances, you have the following data protection rights:

How do we use this information?

We use all of the information we have to help us provide and support our Services. Here is how:

- a. remember information so you will not have to re-enter it during your visit or the next time you visit the Service;
- b. provide, improve, test, and monitor the effectiveness of our Service;
- c. to help you efficiently access your information after you sign in;
- d. monitor metrics such as total number of visitors, traffic, and demographic patterns;
- e. diagnose or fix technology problems;
- f. develop and test new products and features;

How is this information shared?

We will not rent or sell your information to third parties outside Slide Score.

Change of control

If we sell or otherwise transfer part or the whole of Slide Score or our assets to another organization (e.g., in the course of a transaction like a merger, acquisition, bankruptcy, dissolution, liquidation), your information collected through the Service may be among the items sold or transferred. The buyer or transferee will have to honor the commitments we have made in this Privacy Policy.

Legal requests and preventing harm

We may access, preserve and share your information in response to a legal request (like a search warrant, court order or subpoena) if we have a good faith belief that the law requires us to do so. We may also access, preserve and share information when we have a good faith belief it is necessary to: detect, prevent and address fraud and other illegal activity; to protect ourselves, you and others, including as part of investigations; and to prevent death or imminent bodily harm. Information we receive about you may be accessed, processed and retained for an extended period of time when it is the subject of a legal request or obligation, governmental investigation, or investigations concerning possible violations of our terms or policies, or otherwise to prevent harm.

Safety and security

Slide Score has taken appropriate technical and organizational measures by using the latest technologies to protect your information against loss or unlawful processing. We use safeguards to help keep the information collected through the Service secure and take steps (such as requesting a unique password) to verify your identity before granting you access to your account. However, Slide Score cannot ensure the security of any information you transmit to Slide Score or guarantee that information on the Service may not be accessed, disclosed, altered, or destroyed. We request you to do your part to help us. You are responsible for maintaining the secrecy of your unique password and account information, and for controlling access to emails between you and Slide Score, at all times. We are not responsible for the functionality, privacy, or security measures of any other organization.

International transfer
